

**REFURBISHMENT OF THE EXHIBITION AREA OF THE HKMA INFORMATION  
CENTRE—DESIGN AND IMPLEMENTATION (CURRENCY SECTION AND  
HISTORICAL TIMELINE)

It is hereby notified that tenders are invited for the refurbishment of the Exhibition Area of the Hong Kong Monetary Authority (HKMA) Information Centre located at 55th Floor, Two International Finance Centre, 8 Finance Street, Central, Hong Kong.

The Contract requires the tenderer to design and implement the refurbishment of the Currency Section and the Historical Timeline of the Exhibition Area. The area is approximately 244 m<sup>2</sup>.

Tenderers must submit the completed tenders (10 identical hardcopies and one softcopy (stored in a CD-ROM) of Technical Proposal, and one hardcopy and one softcopy (stored in CD-ROM) of Fee Proposal) in separate sealed envelope, which should be marked clearly with the Reference No.: GEN 1/IC/2017 and the subject of the tender on the outside of the envelopes for the respective submissions:—

- (a) Refurbishment of the Exhibition Area of the HKMA Information Centre—Design and Implementation (Currency Section and Historical Timeline) (Technical Proposal)
- (b) Refurbishment of the Exhibition Area of the HKMA Information Centre—Design and Implementation (Currency Section and Historical Timeline) (Fee Proposal)

The envelopes should not bear any indication which may relate the tender to the tenderer. The tender should be addressed to the Tender Box of the Hong Kong Monetary Authority, and delivered by hand to the reception counter situated at 55th Floor, Two International Finance Centre, 8 Finance Street, Central, Hong Kong not later than 12.00 noon (Hong Kong time) on Thursday 6 July 2017. Late tenders will not be accepted.
