#### **OPENING REMARKS**

### Mr Enoch Fung, Chief Executive Officer, AoF

Mr. Enoch Fung is currently the Chief Executive Officer (CEO) of the Hong Kong Academy of Finance (AoF). Mr. Fung joined the HKMA as Adviser (Market Development) in September 2011. He subsequently headed the Financial Stability Surveillance Division and Market Development Division, before taking up his latest role of Head (External) since March 2020, focusing on international financial cooperation initiatives. Prior to joining the HKMA, Mr. Fung was a Senior Economist with Goldman Sachs (Asia), where he specialised in Asia Pacific macroeconomic and investment research.

#### PRESENTATION

#### Dr Keith Chan, Assistant Professor, HKUST

Dr Keith Chan is Assistant Professor at the Division of Environment and Sustainability in HKUST. His research focuses on applying microeconomic and game theories to study the optimal design of green finance taxonomies, the incentive problems in ESG disclosures, and the assessment of corporate net zero transition credibility. His research findings have been mentioned by policy thinktanks and the news. His research team has been nominated by HKUST for the prestigious 'Insight Investment – University of Oxford Prize for Greening Finance' in 2023. Apart from research, Keith teaches ESG management and reporting and environmental economics at the UG and PG levels. He also helped the Hong Kong Institute of Qualified Environmental Professionals (HKIQEP) to develop public education materials on ESG reporting. He obtained his PhD in Economics from the University of Cambridge.

#### Ms Chaoni Huang, Executive Vice President, HKGFA

As Head of Sustainable Capital Markets Asia Pacific, Chaoni leads BNP Paribas's sustainable finance solutions across asset classes for corporates, financial institutions and investors. Leading a growing Sustainable Capital Markets team and working with Global Markets, Capital Markets Group and coverage teams in Asia Pacific and the Banks's global sustainable finance community, Chaoni drives BNP Paribas's continued expansion and leadership in Asian sustainable capital markets.

Chaoni is an industry veteran with over 15 years of experience in sustainable finance having held various ESG-related roles at Natixis, S&P Trucost, MSCI and the United Nations. In addition to her role at BNP Paribas, Chaoni is also highly involved in forwarding Asia's ESG agenda through driving the development of sustainable finance ecosystems, education and advocacy in the region. # <u>Ms Nneka Chike-Obi, Senior Director, Head of APAC ESG Ratings and Research,</u> <u>Sustainable Fitch</u>

Nneka Chike-Obi is Senior Director, APAC Head of ESG Ratings and Research at Sustainable Fitch, overseeing bond, framework and entity-level evaluations (Ratings) and cross-sector thematic analysis (Research) for the region.

Before joining Fitch in 2020, Nneka worked in emerging markets' impact investing and private equity at Acorus Capital in Hong Kong and AgDevCo in London, focusing on the natural resources and industrial sectors in sub-Saharan Africa. She previously worked as a commodities analyst at ICAP and Barclays Capital.

Nneka has an M.Sc. from The London School of Economics and a B.A. from Stanford University.

In February 2024, Nneka was appointed member of the International Capital Market Association's (ICMA's) 2023-2024 Advisory Council of the Principles Executive Committee.
