## Banking (Capital) (Amendment) Rules 2023 - Questions and Answers ("Q&As")

As mentioned during previous consultations, it is our intention to release supplementary guidance in the form of Q&As to the industry in order to facilitate consistent application of the Banking (Capital) Rules ("BCR") as amended by the Banking (Capital) (Amendment) Rules 2023 ("BCAR").

Enclosed is a set of Q&As on the capital treatments of IPO financing and exposures to qualifying central counterparties ("QCCPs") in relation to Swap Connect. This set of Q&As incorporates the explanatory note for IPO financing published earlier for consultation in May 2023<sup>1</sup>, and the Annex to the circular on Swap Connect issued in May 2023<sup>2</sup> (with modifications to reflect the update to the BCR in relation to the calculation of hypothetical capital requirements by QCCPs).

We envisage that the issuance of Q&As will be a continuing process, and the next set to follow will focus on the revised credit risk framework under the Basel III final reform package to address common interpretative issues raised in previous consultations with the industry on the BCAR.
