The Bonds may only be offered and sold to persons outside the United States in "offshore transactions" in accordance with Regulation S. There is no public offering of Bonds in the United States. As such, by submitting bids in connection with the tender, each qualified bidder will be deemed to represent that it is located outside the United States and is not acting for the account or benefit of a person located in the United States.
